**DEFENDANTS' MOTION FOR SUMMARY JUDGMENT
ON AFFIRMATIVE DEFENSES OF RELEASE AND WAIVER**

Defendants, Concert Plantation, LLC (“Concert”) and Plantation Golf and Country Club, Inc. (“Plantation” or the “Club”) (collectively “Defendants”), file their Motion for Summary Judgment on several of their respective affirmative defenses to the Fourth Amended Complaint, and state as follows:

I. INTRODUCTION

There are approximately ninety-eight (98) named Plaintiffs in this consolidated class action.¹ As alleged by the named Plaintiffs, there are approximately seven hundred seventy-five (775) total class members. Approximately five hundred fifty (550), or seventy-one percent (71%), of the class members executed releases in favor of Plantation and Concert, rendering their claims in this action untenable. Plantation and Concert raised these releases in their affirmative defenses to Plaintiffs’ Fourth Amended Class Action Complaint. Plaintiffs failed to file any avoidance negating these defenses. Accordingly, for the reasons set forth below, Plantation and Concert are entitled to judgment as a matter of law on the defense of release.

II. STATEMENT OF UNDISPUTED FACTS APPLICABLE TO THIS MOTION

1. This consolidated class action originally began as three separate lawsuits. The first case was filed over five years ago and was brought by Plaintiff John Dorso, et al., Case No, 2016-CA-5528 on or about October 28, 2016 (the “Dorso Case”). There were 16 plaintiffs in the Dorso Case. Plaintiff Beverley White, *et al.*, filed Case No. 2017-CA-4606 on September 14, 2017 (the “White Case”). There were 85 plaintiffs in the White Case. Plaintiff Joan Yelding, *et al.*, filed Case No. 2020-CA-247NC on January 16, 2020 (the

“Yelding Case”). There were 3 plaintiffs in the Yelding Case. When Plaintiffs filed their Fourth Amended Complaint, they added approximately 41 additional named Plaintiffs.

2. Essentially, all three of the aforementioned cases were consolidated herein and, as of May 6, 2021, the Court deemed Plaintiffs’ Fourth Amended Class Action Complaint (the “Operative Complaint”) filed in this action. The Operative Complaint is brought on behalf of 98 named Plaintiffs and asserts five counts: Count I - Breach of Contract (against Plantation and Concert), Count II - Unjust Enrichment (against Plantation), Count III – Unjust Enrichment (against Concert), Count IV – Fraudulent Transfer (against Plantation and Concert), and Count V – Declaratory Judgment: Account Stated (against Plantation and Concert).

3. Each of Plaintiffs’ claims in the Operative Complaint is based on the underlying premise that, as former equity members of Plantation, Plaintiffs were entitled to a refund of a portion of their equity buy-in to Plantation (the “Refund Amount”) once they reached the top of a waiting list (the “Resignation Waiting Lists”) for their respective categories of membership, : i) golf; ii) tennis; and iii) social. (Operative Compl., ¶¶ 16-19). Each membership category had its own respective Resignation Waiting List. (*See* Transcript of October 14, 2021 Hearing filed with the Court on or about November 1, 2021 (the “October 14 Transcript”), at Page 20, Lines 9 – 12). A copy of the Resignation Waiting List for each membership category is attached hereto as follows: **Exhibit 1** (“Golf Resignation Waiting List”), **Exhibit 2** (“Social Resignation Waiting List”), and **Exhibit 3** (“Tennis Resignation Waiting List”) respectively.

4. The Resignation Waiting Lists consisted of the resigned equity members of Plantation, who were listed in order according to their date of resignation, with those who resigned first at the top of the list.

5. Once a resigned equity member reached the top of their respective Resignation Waiting List, they were next in line to be refunded their respective Refund Amount. The payment of this Refund Amount was contingent on Plantation selling new memberships and a portion of those funds being put in an escrow account. *See* Motion for Class Certification, at page 3; *see also* October 14 Transcript, at Page 20, Lines 13 – 23.

6. These refunds were to be paid according to Plantation’s Bylaws, which were amended over the years. *See* October 14 Transcript, at Page 18, Lines 4 – 8; and Page 19, Lines 2 – 12. A brief timeline of the relevant Bylaw provisions and their amendments is outlined below:

a. March 26, 2001 – Amended Bylaws (the “March 2001 Bylaws”)

3.9.2 The resigned Equity Membership shall be placed on a waiting list to be purchased by the Club. The resigned Membership will be purchased at eighty percent (80%) of the equity portion of the membership fee in effect as of the effective date of the resignation.

3.9.3 Prior to the initial issuance of all Equity Memberships in the resigned Member’s Membership category, every fifth (5) Membership issued in that category shall be a resigned Equity Membership from the resale list.

3.9.4 Although not obligated, the Club may repurchase an Equity Membership under hardship circumstances deemed appropriate by the Board.

b. April 11, 2005 – New Bylaws Adopted (the “April 2005 Bylaws”)

3.9.2 [No Change]

3.9.3 The Club shall maintain an Escrow Account into which monies from the sale of memberships shall be placed. These monies shall be the net amount of monies received after the Club has deducted the Club's initiation or transfer fee. All monies in this account shall be paid out to the resigned categories in accordance with the priority on the Resigned Members Waiting List.

e. November 15, 2010 – Amended Bylaws (the “November 2010 Bylaws”)

3.7.2 The resold Equity membership shall be transferred, and an appropriate Certificate of Membership issued to the purchaser, upon the purchaser's payment of one hundred percent (100%) of the then current Equity Membership price to the Club. Upon receipt of the then current Equity Membership price, the Club will pay to the selling Member the following: eighty percent (80%) of the Equity Membership price originally paid or deemed to be paid by such selling Member in the case of Tennis Equity I or Social Equity I Member, and fifty percent (50%) of the Equity Membership price originally paid by such selling Member in the case of a Tennis Equity II or Social Equity II Member, less any amounts due from the selling member to the Club. In the case of a Regular Equity Member, the Club will pay to the selling Member the following percentage of the Equity Membership price originally paid or deemed to be paid by such selling member, as applicable, less any amounts due from the selling Member to the Club: Regular Equity

Member I – eighty percent (80%); Regular Equity Member II – seventy percent (70%); Regular Equity Member III – sixty percent (60%); Regular Equity Member IV – fifty percent (50%); Regular Equity Member V – forty percent (40%); Regular Equity Member VI – zero percent (0%).

3.8.2 The resigned Equity Membership shall be placed next in line on the Resigned Members Waiting List to be purchased by the Club. The purchase price shall be an amount equal to the percentage of the Equity Membership price originally paid or deemed to be paid by such selling Member for the applicable type and class of Equity Membership set forth in Article 3.7.2 of these Bylaws.

g. April 1, 2016 – Amended and Restated Bylaws (the “April 2016 Bylaws”)

3.7.1 The Club currently offers Equity Memberships with a non-refundable equity portion of the Joining Fees. Nevertheless, if a resigned member is entitled to receive a refund of a percentage of the equity portion such member paid to the Club pursuant to the Prior Bylaws (“Refundable Equity Member”), the Club shall refund the Refundable Amount to such resigned member in accordance with these Bylaws. The “Refundable Amount” in each such case shall be equal to eighty percent (80%) of the equity portion of the Joining Fees the Club receives for issuance of an Equity Membership to a new Equity Member, less any amounts still owed to the Club by the resigning member. Notwithstanding the preceding sentence, the Club shall not pay any Refundable Amount until the Joining Fees have been paid in fully by the new member.

3.7.2 The Club previously issued, but is no longer offering, Regular Equity Memberships. For purposes of repayment of a Refundable Amount, resigned Regular Equity Memberships shall be considered to be in either the Full or Golf Equity Membership category, as applicable, and resigned Regular Equity Memberships shall be placed on the same Resigned Members Waiting List as Full and Golf Equity Memberships. Resigned Tennis Equity Memberships and Social Equity memberships shall be placed on the respective separate Resigned Members Waiting List accordingly.

3.8.2 If a Refundable Equity member resigns, the resigned Equity Membership shall be placed next in line on the Resigned Members Waiting List in order to receive from the Club the Refundable Amount, if any, upon payment to the Club of the then current Joining Fees by a new member.

3.8.3 The Club shall maintain an escrow account into which the Club shall deposit eighty percent (80%) of the equity portion of the Joining Fees paid by each new Equity Member (the "Escrow Account"). All monies in the Escrow Account shall be paid out to the applicable resigned members in accordance with the priority on the Resigned Members Waiting List. Within thirty (30) days of the Club's receipt of the Club's receipt of one hundred percent (100%) of the Joining Fees, the Club will pay to the resigned member in the first position on the Resigned Members Waiting List the applicable Refundable Amount, if any. Notwithstanding anything to the contrary in these Bylaws, the Escrow Account shall be the sole source of funds used to pay Refundable Amounts, if any, to resigned members. From and after the date upon which all Refundable Amounts which may be payable to Refundable Equity members have been paid, the Escrow Account will be closed and terminated.

3.8.4 [No Change]

7. The refund payments were only to be paid from an escrow account funded by the sale of new memberships net Plantation's initiation or transfer fees (the "Escrow Account"). *See* Motion for Class Certification, at page 3; *see also* October 14 Transcript, at Page 20, Line 13 – Page 21, Line 2 and Page 21, Line 10 – Page 22, Line 12. To the

extent there were no funds in the Escrow Account due to no new memberships being sold, no resigned equity members would be paid their Refund Amount. *See* October 14 Transcript, at Page 35, Line 14 – Page 36, Line 2.

8. On November 15, 2018, Plantation entered into a Purchase and Sale Agreement (the “PSA”) whereby it agreed to sell certain Club assets to Concert. The sale of these assets was effectuated as of February 2, 2019. *See* October 14 Transcript, at Page 35, Lines 14 – 19. Upon the sale of Plantation’s assets to Concert pursuant to the PSA, Plantation ceased operating as a club and ceased selling new club memberships. *Id.* at Page 35, Lines 14 – 22. As a result, no additional funds have been added to the Escrow Account since the sale from Plantation to Concert.

9. From the date the April 2016 Bylaws were adopted until Plantation sold its assets to Concert, Plantation sold a total of 124 Golf Equity Memberships contributing \$147,080.00 towards the Escrow Account (October 14 Transcript, at Page 32, Lines 19 – 23 and Page 34, Line 20 – Page 35, Line 1), 20 Tennis Equity Memberships contributing \$9,600.00 towards the Escrow Account (October 14 Transcript, at Page 41, Lines 11 – 25), and 40 Social Equity Memberships contributing \$9,600.00 towards the Escrow Account (October 14 Transcript, at Page 38, Line 14 – Page 29, Line 14). Those funds were used in accordance with the Bylaws to pay out the resigned equity members at the top of the Resignation Waiting Lists.

10. Specifically, prior to the sale of the Club assets to Concert, Plantation issued golf equity refunds in the amount of \$1,200.00 per member, which were sent to 100 equity members on the Resignation Golf Waiting List (October 14 Transcript, at Page 33, Lines 14 – 19) 85 of which were cashed. *Id.* at Page 35, Lines 6 – 13. (“Refunded Resigned Golf

Equity Members”). Additionally, Plantation issued tennis equity refunds in the amount of \$480.00 per member, which were accepted by 20 equity members on the Resignation Tennis Waiting List (*Id.* at Page 41, Lines 11 – 25) (“Refunded Tennis Equity Members”). Finally, Plantation issued social equity refunds in the amount of \$240.00 per member, which were sent to and accepted by 37 social members on the Resignation Social Waiting List (*Id.* at Page 38, Line 17 – Page 39, Line 20) (“Refunded Social Equity Members”). All of the aforementioned payments were made between the time the April 2016 Bylaws were adopted and the time Plantation sold its assets to Concert.

11. Notably, some of the resigned equity members on the Resignation Waiting Lists owed monies to Plantation. Thus, any Refund Amount due to them would be offset by those amounts due Plantation, with any delinquent funds being retained by Plantation.²

12. As part of the sale of Plantation’s assets, Concert offered to pay all of the resigned equity members in exchange for their release of any claims against Plantation or Concert related to their former membership in Plantation. Approximately 775 releases memorializing this offer were sent out to the Resigned Equity Members. *See* October 14 Transcript, at Page 48, Lines 9 – 13. Approximately 550 of the offers memorialized by the Releases were accepted when they were executed and returned, at which time Concert paid each Resigned Member in accordance with the Releases. *Id.* at Page 48, Line 14 – Page 49, Line 1. Those who executed Releases shall be referred to herein, collectively, as the “Releasing Resigned Equity Members”. With respect to former tennis equity members, all members on the Resignation Waiting List accepted payment, thereby releasing all claims against Concert and Plantation. Examples of the Receipt and Releases of Social, Golf, and

Tennis Resigned Club Members executed by these resigned equity members are attached hereto as **Composite Exhibit 4** (the “Releases”).

13. Notably, the following named Plaintiffs are some of the Releasing Resigned Equity Members: Raymond Wopperer, Joseph G. Brisch, Patricia McGowan, Ross Dunbar, Robert A. Beaver, Jean M. Morgan, Thomas Slattery, Dominick Giambrone, David Gartzke, Pamela Holcombe, as attorney in fact for Marvin W. Pruitt, Patricia Thinnes, and Nancy A. Bugosh (the “Releasing Plaintiffs”). The Releasing Plaintiffs’ Releases are attached hereto as **Composite Exhibit 5**.

The Class

14. Based on the above facts, the Complaint sought to certify a class of Plaintiffs defined as follows:

All individuals (or their guardians or representative) who had an effective Resigned Equity Membership before April 1, 2016 and have not received their full Refund Amount. Excluded from the Class are Defendants, any officers or directors thereof, together with the legal representatives, heirs, successors, or assigns of any Defendant, and any judicial officer assigned to this matter and his or her immediate family.

(the “Proposed Class”) (*See* Operative Compl., ¶ 32).

15. Effectively, Plaintiffs’ Class consists of everyone on the Resignation Waiting List for each membership category, without exception, at the time that the April 2016 Bylaws went into effect. Plaintiffs’ Class includes all of: i) the Refunded Resigned Golf Equity Members; ii) the Refunded Resigned Tennis Equity Members; iii) the Refunded Social Equity Members; iv) the Releasing Plaintiffs v) Releasing Resigned Equity Members; vi) the Plaintiffs themselves; and vii) every other resigned equity member still on the Resignation Waiting List, regardless of their position on that list or the specific version of the Bylaws under which those individuals resigned.

16. On December 6, 2021, following hearings on October 13, 2021, October 14, 2021, and November 1, 2021, the Court entered an order granting Plaintiffs' motion or class certification (the "Class Certification Order"). *See* DIN 784.

17. On December 16, 2021, Concert appealed the Class Certification Order. *See* DIN 802.

18. On December 17, 2021, Plantation appealed the Class Certification Order. *See* DIN 805.

19. Both appeals are currently pending.

Defendants' Affirmative Defenses

20. On May 25, 2021, Concert filed its Answer and Defenses to the Operative Complaint ("Concert's Answer and Defenses"). *See* DIN 505. Concert's first and second affirmative defense asserted therein state as follows:

FIRST DEFENSE

Plaintiffs' and the purported Plaintiff Class' claims are barred, in whole or in part, because certain Plaintiffs have settled their claims and released Concert and PGCC from any and all liability associated with any additional refund payments.

SECOND DEFENSE

Plaintiffs' and the purported Plaintiff Class' claims are barred, in whole or in part, by the doctrine of waiver, as certain Plaintiffs have voluntarily relinquished any right to any additional refund payments.

21. On May 26, 2021, Plantation filed its answer and affirmative defenses to the Operative Complaint ("Plantation's Answer and Defenses"). *See* DIN 506.

22. Plantation's second and third affirmative defenses state as follows:

Second Affirmative Defense. Plaintiffs' and the purported Plaintiffs' Class's claims are barred in whole or part based on the doctrine of release. Specifically, certain Plaintiffs have executed releases in favor of PGCC,

which released PGCC from any and all liability with respect to the asserted claims.

Third Affirmative Defense. Plaintiffs’ and the purported Plaintiffs’ Class’ claims are barred in whole or part based on the doctrine of waiver. Specifically, certain Plaintiffs have voluntarily relinquished their right to any additional refund by accepting the amount tendered by PGCC pursuant to the Bylaws as amended from time to time, which constitutes an accord and satisfaction of the alleged debt.

23. Plaintiffs did not file an avoidance of any of these defenses.

III. ARGUMENT

A. Summary Judgment Standard.

The Supreme Court of Florida recently made two amendments to Florida Rule of Civil Procedure 1.510 regarding summary judgments. First, on December 31, 2020, the Court amended the Rule to “align Florida’s summary judgment standard with that of the federal courts. . . .” *In re Amends. to Fla. Rule of Civ. Pro. 1.510*, 309 So. 3d 192, 192 (Fla. 2020). Then, on April 29, 2021 the Court further amended the Rule “to adopt almost all of the text of Federal Rule of Civil Procedure 56” and the “federal summary judgment standard.” *In re Amends. to Fla. Rule of Civ. Pro. 1.510*, No. SC20-1490, p. 22 (Fla. Apr. 29, 2021) (Court Notes, 2021 Amendment). Florida now “adhere[s] to the principles established in the *Celotex* trilogy. In the broadest sense, those cases stand for the proposition that ‘summary judgment procedure is properly regarded not as a disfavored procedural shortcut, but rather as an integral part’ of rules aimed at ‘the just, speedy and inexpensive determination of every action.’” *Id.* at p. 5 (citation omitted). The amendments govern any summary judgment motion decided on or after May 1, 2021. *Id.* at p. 13.

The new Rule abandons “certain features of Florida jurisprudence that have unduly hindered the use of summary judgment in” Florida. *In re Amends. to Fla. Rule of Civ. Pro.*

1.510, 309 So. 3d at 192-93. It is now no longer “plausible to maintain that ‘the existence of *any* competent evidence creating an issue of fact, however credible or incredible, substantial or trivial, stops the inquiry and precludes summary judgment, so long as the ‘slightest doubt’ is raised.” *In re Amends. to Fla. Rule of Civ. Pro. 1.510*, No. SC20-1490 at p. 8. The new test “is whether ‘the evidence is such that a reasonable jury could return a verdict for the nonmoving party.’” *Id.* at p. 7. If a party’s story on which a claim is based is “blatantly contradicted by the record . . . a court should not adopt that version of the facts” when ruling on a motion for summary judgment. *Id.*

B. The Releasing Resigned Equity Members, including the Releasing Plaintiffs, have released their claims.

Florida law governing releases is well established. To that end, courts have concluded as follows:

Under Florida law, a general release encompasses all claims or demands which had matured at the time of its execution. Releases are contracts, thus, are to be governed and interpreted according to well-settled principles of contract law. Consequently, it is a deeply rooted principle of Florida law that the intent of the parties controls interpretations of their releases. Further, as the language used in [a] release is the best evidence of the parties’ intent where the phrasing is clear and unambiguous, a court cannot indulge in construction or interpretation of its plain meaning.

Santana v. Miller, 314 So. 3d 346, 348 (Fla. 3d DCA 2020) (internal quotations and citations omitted); *see also Philip Morris USA, Inc. v. Skolnick*, 171 So. 3d 747, 753 (Fla. 4th DCA 2015) (opining that “[t]he threshold inquiry in interpreting a release or covenant not to sue is whether its terms are unambiguous, i.e., whether there is no reasonable basis for a difference of opinion” and “[i]f the release or covenant not to sue is clear on its face, its construction is a matter of law, appropriate for summary judgment resolution.”) (internal quotations and citations omitted).

The releases at issue in this action state, in pertinent part, as follows:

WHEREAS, the undersigned was a member (Resigned Club Member) who resigned their golf membership in Plantation . . .

WHEREAS, Resigned Club Member is eligible at some time in the future for a refund of a portion of the membership contribution previously paid by the Resigned Club Member to [Plantation] . . . in an amount which cannot be determined at this time, and the Resigned Club Member is hereby accepting early payment of such in the amount set forth below in full and complete satisfaction of any such future payment obligation to the Resigned Club Member.

WHEREAS, As a condition to the Resigned Club Member receiving early payment in connection with their Resigned Membership in [Plantation] . . . Resigned Club Member is to complete, sign, date and deliver this Release without alteration of its printed terms to . . . Concert.

NOW THEREFORE, in consideration of the payment by Concert to Resigned Club Member of the sum of \$1,200.00, the Resigned Club Member hereby: (i) fully relinquishes and releases any and all rights to any further or future payment from [Plantation] or Concert relating in any way to the Resigned Club Member's membership in Plantation, (ii) fully and finally releases Concert and [Plantation] . . . from any and all claims, liabilities, complaints, obligations, or requests in any way relating to Resigned Club Member's Resigned Membership in [Plantation] known or unknown . . . and (iii) forever terminates, waives and fully releases any title, interest or right to any refund or payment of any type or nature in any way associated with Resigned Club Member's Resigned Membership in [Plantation].

See Exhibits 4, 5. A simple review of the releases is enough to reveal that the language contained therein is clear and unambiguous, and that said language evidences the parties' intent that those who executed a release, and received compensation in exchange, thereby completely released Plantation and Concert from any and all claims, known or unknown, specifically including any claim to a refund payment in any way associated with the Resigned Member's Resigned Membership. There is simply no reasonable basis for a difference of opinion on this interpretation. Both Plantation and Concert raised the releases as affirmative defenses to Plaintiffs' Complaint and have relied on same throughout this

action. Plaintiffs, for their part, failed to reply to the release defense, thereby waiving any right to avoid the defense.³ Therefore, based on the pleadings before the Court on this issue, there are no genuine issues or material fact and Defendants are entitled to judgment as a matter of law that the releases are valid and enforceable and that the claims of any named Plaintiff or class member are barred by their execution of their respective release.

At a hearing on February 8, 2022, the Court ruled that, for purposes of the March 2022 hearing on Plaintiffs' Motion for Summary Judgment, it will only consider the language contained on face of the Releases themselves. As more fully discussed above, the language of the Releases is clear and unambiguous. Simply put, the Releases constitute enforceable contracts, and this Court is required to enforce them, thereby barring all of the claims by the Releasing Plaintiffs and Class Members that executed the Releases. There is no record evidence that the Releases are unenforceable on their face. Accordingly, Plaintiffs are entitled to summary judgment on the affirmative defense of release.

IV. CONCLUSION

Based upon the foregoing, Defendants respectfully request that the Court enter judgment in their favor on Concert's first and second affirmative defenses and on Plantation's second affirmative defense, specifically finding that the claims of any named or putative Plaintiff who signed a release in the form attached hereto as Exhibits 4 or 5 are

barred in totality, and awarding Defendants such other and further relief as the Court deems just, equitable and proper.






