PGCC CLASS ACTION LITIGATION - UPDATE

Dear Class Members:

On April 14, 2022, the Court issued an Order denying our Motion for Partial Summary Judgment. Thereafter, on May 13, 2002, the Court, relying on its prior reasoning, issued a verbal Order granting Plantation Golf and Country Club, Inc. ("PGCC") and Concert Plantation, LLC's ("Concert") Motion for Summary Judgment on all claims made by the Class.

While this is not the outcome we hoped for, please do not be discouraged by this news. This case is **NOT** over and we will continue to push forward.

Currently appeals by PGCC and Concert remain pending on the issue of Class Certification.

Once these pending appeals are decided, the Court will likely issue a Final Judgment for the defendants. Then, the class may file an appeal of the Court's summary judgment decision. Unfortunately, appeals take many months before they are decided. For this reason, we probably will not have updates to share for some time. Do not let this worry you. Remember, this case is a marathon - not a sprint - and the race is far from over.

We continue to diligently fight to obtain justice on your behalf.
