The colors blue, black, green, orange, yellow, red, brown, and white are claimed as a feature of the mark.

The mark consists of three concentric circles surrounding a central light blue disk. Around the circular seal in the field are four seven-pointed stars in black, in each corner, on a white background.

The non-Latin characters in the mark transliterate to "A NI GI DU WA GI ANI YV WI YA" and this means "THEY ARE KEEETOOWAH. THEY ARE ALL NATIVE PEOPLE." in English.

Requirements in the First Ten Years*

What and When to File:

If the declaration is accepted, the registration will continue in force for the remainder of the ten-year period, calculated from the registration date, unless cancelled by an order of the Commissioner for Trademarks or a federal court.
- **Second Filing Deadline:** You must file a Declaration of Use (or Excusable Nonuse) and an Application for Renewal between the 9th and 10th years after the registration date.* See 15 U.S.C. §1059.

- You must file a Declaration of Use (or Excusable Nonuse) and an Application for Renewal between every 9th and 10th-year period, calculated from the registration date.*

Grace Period Filings*

The above documents will be accepted as timely if filed within six months after the deadlines listed above with the payment of an additional fee.

***ATTENTION MADRID PROTOCOL REGISTRANTS:** The holder of an international registration with an extension of protection to the United States under the Madrid Protocol must timely file the Declarations of Use (or Excusable Nonuse) referenced above directly with the United States Patent and Trademark Office (USPTO).
